Representation Submitted by Mr D R Holmes to Support his Deputation

INTRODUCTION

An alteration is required to the Experimental Traffic Regulation Order ("ETRO") for Langstone Avenue to enhance road safety and to avoid future costs to myself, other residents and HBC. The turning circle at its east end should be double yellow lined and if necessary the loss of the two parking places there should be compensated by making two additional time-restricted parking places outside my frontage on to the Avenue. This and other minor modifications to the ETRO appeared to be generally agreed at the workshop on 12 November 2014 but this one was not promulgated because your traffic engineer, Mr Seebohm, did not feel it was necessary. He and some residents did not have a full knowledge of the history of the turning circle and other relevant facts listed below:

calls, car mileage plus much inconvenience to residents at eastern end of Avenue and in the private close. Well known safety issues of heavy reversing vehicles saying UNSUIT-ABLE FOR HEAVY VEHICLES, TURNING DIFFICULT

2002 – present. Sporadic incidents like those in 1992 ~ 2000. HBC fence posts knocked down and panels of my featheredge fence stove in. Minimal as in most cases I was able to catch the culprits and get the panels replaced at their expense.

CONCLUSION

The two parking places in the turning circle at the eastern end of Langstone Avenue should be eliminated by substituting double yellow lines and, if necessary, two compensating parking places can be provided outside my house. This will help to avoid the endless costs and difficulties to residents and HBC similar to those detailed above
