1.0 Purpose of Report

1.1 To make minor changes to the process to be followed by the Governance & Audit Sub-Committee at Hearings convened following an investigation into whether a Borough Councillor has breached the Council's Code of Conduct.

2.0 Recommendation

That: the Committee recommend to Council that the Council's Process for dealing with allegations be amended as follows:

- (i) reference to the "Governance Committee" be amended so as to read "Governance & Audit Committee"
- (ii) The procedure for hearings be amended to ensure that a separate process for hearings convened following an investigation be added as Appendix 3 to the process.

3.0 Summary

3.1 The making of minor amendments to the processes to be followed at a hearing of the Governance & Audit Sub-Committee is recommended in order to ensure any such hearings run efficiently and in the interests of justice.

4.0 Subject of Report

4.1 The current process for dealing with allegations that a Councillor has failed to comply with the Council's Code of Conduct was made

following significant changes to the law relating to the conduct of Councillors made by the Localism Act 2011.

- 4.2 The process sets out the procedures to be followed by the Council in the event that a complaint is made about the failure of a Councillor to comply with the Council's Code of Conduct. The proposed changes to the process gives more detail to the process to be followed in the event that the initial assessment team send a complaint for investigation. The purpose of the changes is to try to make sure that any hearing of a Sub-Committee convened following an investigation runs efficiently and is fair for all the parties.
