This report seeks to appoint Head of Corporate Finance as the S151 Officer and the Executive Head of Internal Services as Deputy Electoral Registration Officer

- 5.1. Current situation / proposal re s.151 Officer
- 5.1.1. Mr Steve Pink as Chief Finance Officer was designated as the statutory officer for the purposes of s151 Local Government Act 1972 by January Council. Unfortunately, Mr Pink is unable to start in this role until next month and the previous incumbent who was covering the role on a interim basis left the

- organisation in February. This has meant that for the intervening period no officer has responsibility for the functions set out in section 151.
- 5.1.2. To cover this gap, a stand-in will be required and this report recommends that this be the current Deputy s.151 Officer, namely the Head of Corporate Finance.
- 5.1.3. This officer will be designated to this role until the permanent Chief Finance Officer is able to start on 3rd April 2023 when the designation will revert to Mr Pink as Chief Officer as per the decision made in January Council aforesaid.

5.2. . Current situation / proposal re Electoral Registration Officer

- 5.2.1. The Electoral Registration Officer is responsible for the preparation and maintenance of the registers of parliamentary electors for any parliamentary constituency (or part of a constituency) within its area, and of local government electors for its area
- 5.2.2. The Chief Executive Officer currently performs the statutory function of Electoral Registration Officer (ERO) (who is designated as the Proper Officer for these functions within the Council's Constitution)
- 5.2.3. In view of the forthcoming local elections, it is considered prudent and necessary to designate an officer as Deputy ERO and this report recommends that this be designated to The Executive Head of Service for Internal Services.

- 8.2. Sections 52 Representation of the People Act 1983 anticipates that that every local authority shall appoint an ERO who shall comply with any general or special directions which may be given by the Secretary of State with respect to the arrangements to be made by the registration officer for carrying out his or her functions under this Act.
- 8.3. Specifically, section 52(2) of the above Act provides that any of the duties and powers of an ERO may be performed and exercised by any deputy for the time being approved by the council which appointed that officer.
