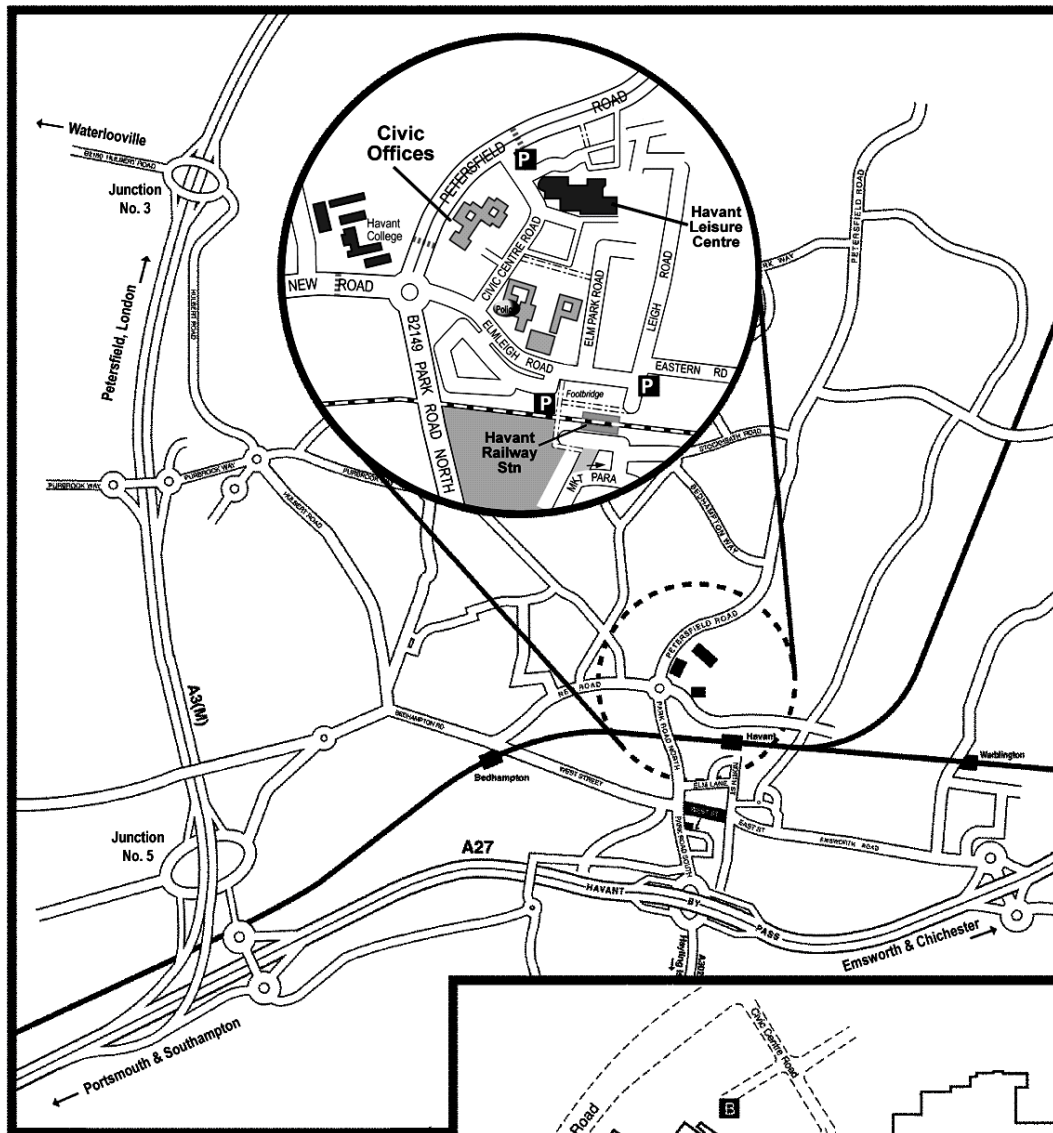
PROTOCOL AT MEETINGS – RULES OF DEBATE

Rules of Debate

- Councillors must always address each other as “Councillor ...” and must always address the meeting through the Chairman;
- A motion must relate to the business included on the agenda or accepted by the meeting as urgent business
- A motion must be proposed and seconded before it is debated until it is either accepted or rejected by a vote;
- An amendment can be proposed to the original motion and this must be seconded before it is debated;
- An amendment cannot be considered if it is inconsistent with an amendment previously adopted or repeats an amendment previously rejected;
- The mover of an original motion may, with the consent of the mover of an amendment, incorporate an amendment into the motion;
- Only one amendment may be moved at a time. No further amendments can be moved until the previous amendment has been dealt with;
- Each amendment must be voted on separately;
- If an amendment is carried, the amended motion becomes the substantive motion to which further amendments may be moved;
- If an amendment is lost, other amendments may be moved to the original motion.
- The mover may withdraw an amendment at any time
- After an amendment has been carried, the Chairman will read out the amended (substantive) motion, before accepting any further amendment, or if there are none, put it to the vote.

Voting

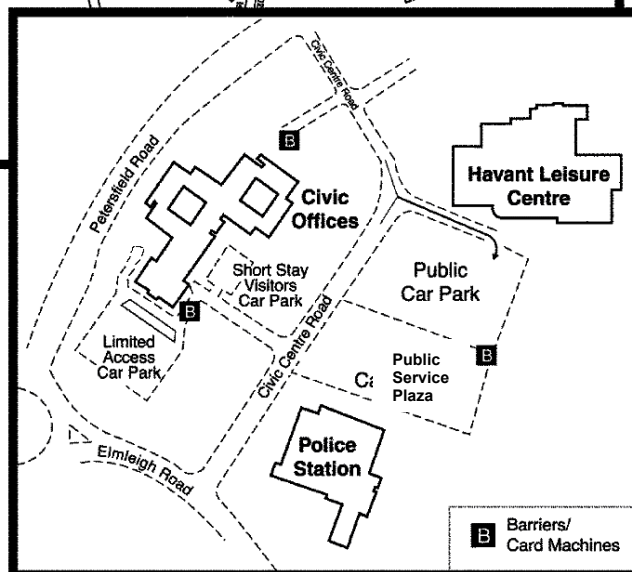
- Voting may be by a show of hands or by a ballot at the discretion of the Chairman;
- Councillors may not vote unless they are present for the full duration of the item;
- Where there is an equality of votes, the Chairman may exercise a second (casting) vote;
- Two Councillors may request, before a vote is taken, that the names of those voting be recorded in the minutes
- A recorded vote will always be taken in respect of approval of the Annual Budget
- Councillors may not vote unless they are in the meeting for the full debate on any particular item
- A Councillor may request that his/her vote be recorded in the minutes

Motorhome Parking Beachlands **Report by Michelle Green**

FOR DECISION

Key Decision: No

1.0 Purpose of Report

- 1.1** To approve the implementation of the amendments to the Car parking Order as advertised with the amended times of operation as 9am – 6pm.

2.0 Recommendation

- 2.1** To implement the proposal to move all overnight motor home parking to the designated area behind the skate park, in marked out zones.
- 2.2** To implement the proposal to change the overnight motorhome parking to 3 nights with no return in 4 nights
- 2.3** To implement the proposed new description of a motorhome in the order
- 2.4** In addition to the proposed changes the charging period for the car parks along beachlands from 8am – 6pm to 9am – 6pm. The overnight timing to be changed from 10pm – 8am to 7pm – 9am to allow for better enforcement of the overnight parking.

3.0 Summary

- 3.1** The car parking area known as West Beach has accommodated overnight parking for motorhomes since 2009. The current Car Parking Order states they can stay for up to 72 hours and there is a charge of £15 for the peak season and out of season the charge is £10. This is the only area along beachlands they can park overnight and in any area they choose.
- 3.2** During the day motorhomes may park in any of the beachlands car parks and pay the normal daily rate.

4.0 Subject of Report

- 4.1** Over the recent seasons there has been a noticeable increase in motorhomes and motorhome type vehicles using the car park at West beach. This raised safety concerns regarding the manner in which they are parked for an overnight

stay and that they were parked too close together without a suitable distance between them. A solution was required to enable the motorhomes to continue to stay over night but in a controlled and safe manner. Moving the overnight parking into one specified area with marked out zones for them to park in will achieve safer and controlled parking.

- 4.2 Enforcement of the current overnight restrictions is difficult due to the wording of the current Car Park Order, operational times of the car park, staffing rotas and the manner in which these vehicles can be utilised to travel to the shops and restaurants and back. Changing the hours of operation, definition of motorhomes and the wording from hours to number of days permitted to stay within the car park will allow for robust enforcement to be undertaken. The staff will be available daily to undertake enforcement and the changed description will include any modified vehicles used for sleeping in as would a motorhome. By changing the wording from hours to days this removes the issues of a vehicle moving and returning on the same day from an enforcement point of view.
- 4.3 There is a demand for overnight parking to be permitted in this area and by making these amendments to the current Car Park Order there will be a balance between meeting the demand whilst addressing the safety concerns and responsibilities the Council have.
- 4.4 There were 51 objections to the new proposals received and one in support of the proposals. Appendix 1 provides a summary of these and the response to them.

5.0 Implications

- 5.1 **Resources:** Funding for the works to be carried out will be met from existing Council budgets for car park works.
- 5.2 **Legal:** The Order will be made under the provisions of its powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984
- 5.3 **Strategy:** These proposed changes support the following themes set out in the Corporate Strategy; financial sustainability and public service excellence
- 5.4 **Risks:** There is a risk that there will not be sufficient room on some weekend nights to accommodate the number of visiting motorhomes wanting to stay overnight.
- 5.5 **Communications:** Interested parties were notified of the proposals by means of notices, information on the Council's website and in the local press as per the Council's statutory duties.
- 5.6 **For the Community:** By controlling the overnight parking it will have a positive impact on the local area and reduce inconsiderate use and improve safety
- 5.7 **The Integrated Impact Assessment (IIA) has been completed and concluded the following:** There are no concerns about the proposals having a differential impact.
- 6.0 **Consultation** Interested parties were notified of the proposals by means of notices, information on the Council's website and in the local press as per the Council's statutory duties
