#### Introduction

This scrutiny review was undertaken in response to concerns raised by the Scrutiny Board at its meeting on 27 June 2017.

Members were concerned that the grass cutting and weed clearance programme had not been carried out to the usual high standard, and were eager to ensure that this did not reoccur in future years.

As part of our review, we sought information from the key officers as to how the programme is undertaken and resourced.

We also invited the Operations Director for Norse South East and the Strategic Procurement Project Manager to meet with us to discuss these concerns and ascertain the measures being put in place to ensure this is not repeated.

The Panel were confident that past mistakes would not be repeated, but considered that there were a few improvements that could be made to further improve the grass cutting and weed clearance programme in the Borough.

#### **RECOMMENDATIONS**

- 2.2 That the Scrutiny Board be recommended to include a review of the performance of this service in its 2017/18 and 2018/19 Work Programmes. This review will include a meeting at the commencement of the 2018 programme to discuss the proposed schedule of works and a meeting at the end of the 2018 programme to review how the service has performed during the season.

#### CONCLUSIONS

- 10.1 The Panel is confident that the measures introduced this year to overcome the problems experienced with the grass cutting and weed clearance are robust and will reduce the risk of such problems reoccurring in future programmes.
- 10.2 Arrangements should be put in place to keep Councillors informed of the performance of this service throughout the year. This will enable Councillors to respond to residents' enquiries and complaints.
- 10.3 Councillors and residents should be encouraged to use the Council's complaints data base (CRM) to enable the officers and Norse South East to easily identify the scope of any issues and respond quickly.
- The performance of this service should be reviewed by a scrutiny panel both prior to and after the 2018 grass cutting / weed clearance programme.

#### **METHODOLOGY**

#### Scope

The review was established following complaints raised by Councillors at the Scrutiny Board meeting on 27 June 2017. The review would investigate the concerns raised over the grass cutting / weed clearance programme for the summer 2017.

#### **Link with the Corporate Strategy and Business Plans**

This project links to the Council's pride in the Borough and the commitment to improving neighbourhoods and their quality. This project also links to the Council's drive for innovative and creative partnership working, with this evident in Norse South East.

#### Benefits to the Council and its residents

Grass cutting is a very visible Council service that impacts upon the aesthetics of the Borough and contributes greatly to a pleasant and attractive environment for residents to live in.

#### Methodology

The review was requested at the Scrutiny Board meeting on 27 June 2017. However, due to the workload of the Operations etc. Scrutiny and Policy Development Panel, the review was delayed to January 2018.

The Panel canvassed all councillors to ascertain their concerns relating to the performance of the grass cutting and weed clearance. The Panel also invited the Operations Director of Norse South East and the Strategic Procurement Project Manager, to discuss the difficulties experienced in the summer of 2017, the concerns raised by Councillors and measures to overcome the problems experienced in future years.

## **Key Findings**

(Review of Grass Cutting and Weed Clearance in the Borough)

Operations, Environmental Services and Norse Scrutiny and Policy Development Panel



#### **KEY FINDINGS**

- 11.1 The Panel has found that the grass cutting and weed clearance programme for 2017 was not carried out to the usual standard due to an unprecedented growth of weeds and grass, poor weather conditions, and a delay in identifying that there was problem with the performance of the service and responding to the issue.
- 11.2 The delay in recognising the extent of the problem and reacting accordingly was due in part to a failure to collate all the complaints onto one system. Although members of the public were reporting their concerns, they did so mainly by contacting officers and Councillors directly and these complaints were not fed into the Council's data base (CRM). Therefore, the official records did not record the true scale of the problem. Recommendations 2.1.3 and 2.1.4 seek to stop this occurring in the future.
- 11.3 A failure of the Council to introduce a system to monitor the performance of the grass cutting and weed clearance programme also contributed to the delay in responding to the problem. The Panel was pleased to learn that a monitoring system has been introduced to ensure the works are completed within an agreed schedule, and if not, reasons for the failure are recorded. These changes will enable Norse to effectively assign resources to the right areas in the Borough, and enable the Council to accurately monitor the performance of the service and react if standards begin to slip (full details of the measures are set out Section G of the Findings Pack). The Panel are confident that the necessary robust measures are being put in place to reduce the risk of these problems happening again. Recommendation 2.1.1 asks the Cabinet to endorse these measures.
- 11.4 The Panel was also pleased to learn that Norse South East has revised its working methods to improve the service provided to the Council. These new methods make the service more flexible and able to react quickly to resolve issues that arise during the cutting/clearance season. Recommendation 2.1.1 asks the Cabinet to endorse these measures.
- 11.5 A failure to keep Councillors up to date with the issues at the beginning of the season did not help the situation. Councillors play an important role keeping their constituents informed about issues, and preventing and resolving complaints. It is therefore imperative that Councillors are kept up to date on sensitive areas such grass cutting/weed clearance The Panel acknowledge that towards the end of the season regular reports were submitted to Councillors. The Panel consider that reports on the progress of the programme should be submitted to Councillors on a regular basis, to enable quick reference in response to any queries from residents. Recommendation 2.1.2 seeks to implement this measure.
- 11.6 While assured by the measures suggested by the officers, the Panel are keen to ensure these problems do not arise in the coming summer period. As such, the Panel will meet with the key officers before the season to discuss the

coming programme, and following the season to analyse the work undertaken, as per recommendation 2.2

#### Hampshire County Council Grass Cutting Specification

All grass shall be cut cleanly and evenly, to the same height (approximately 25mm) on each site and without damaging the existing surface.

The Contractor shall complete all required grass cutting operations within each parish/ward boundary before to moving onto the next area. The parish/ward boundaries can be found on the ESRI ArcGIS shape files provided by the Service Manager.

The Contractor shall be required to re-cut any area failing to meet the requirements of this Service Activity at its own expense.

The Contractor shall remove all grass clippings arising deposited on paved areas, private drives, channels, etc. by a method approved by the Service Manager. Generally this shall be by sweeping or by the use of a 'leaf blower'. This shall be undertaken within a reasonable timescale and by no later than the end of the day when the grass is cut. The arising shall be either removed from site and disposed or dispersed evenly over the grass surface area.

The Contractor shall leave a 100mm margin around all areas that contain visible evidence of bulbs or corms. These areas shall not be cut until a minimum period of 6 weeks has lapsed after completion of flowering.

In conditions of drought, the Contractor shall ask the Service Manager to stipulate the height that grass shall be cut for each site.

In very wet conditions, the Service Manager may request that all operations involving grass cutting shall cease, until conditions allow operations to continue without:

- i Damaging the surface, levels and contours of the ground;
- ii Creating grass cutting 'divots' from the rollers or cutters.

The Contractor shall resume normal grass cutting operations once the ground conditions become suitable again. If there is a substantial amount of mowing time lost through adverse conditions, the Contractor shall be expected to provide sufficient manpower and machinery to make the necessary progress required in order to return to the initially agreed programme. If very wet conditions persist and additional operations are required to cut grass, the Service Manager shall issue a separate instruction to the Contractor for dealing with excess growth.

The Contractor shall be responsible for ensuring that the area of grass to be cut is clear of any parked vehicles and ensure the grass cutting operations is undertaken in accordance with Volume 1, Section 5.33: Notices to the Public, Advanced Signing and Dealing with Parked Cars.

All persons operating grass cutting Equipment shall be satisfactorily trained and the Service Manager reserves the right to ask the Contractor to provide adequate proof that the operators are suitably trained, conversant with Health and Safety legislation and competent in their operating methods.

#### Factors that can affect the performance of the Service

- Adverse weather conditions
- Problem areas (roads with speed limits over 40mph and areas with French Drains)
- Vehicles parking on verges (contact HCC if vehicles on verges interfere with the weed clearing grass cutting schedule)
- Staffing levels
- Condition of the verges

#### Problems with Completing the highway grass/weed clearing in 2017

- Weather conditions led to an unprecedented volume of weed growth and at the same time limited the number of cuts/spraying that could be undertaken
- Resources directed to the wrong areas
- Complaints were not made via the CRM which made it difficult to assess the level of the problem and hotspots
- The Council did not have arrangements to monitor the performance of the service

#### Actions taken in 2017 to rectify the problem

- Introduced a new team to deal with significant weed growth
- Managers prioritised areas based on site visits and information received from complainants and Customer Services
- Overtime work (if resources allowed)
- Employed a contractor

- Daily update reports circulated to Council's liaison Officer
- Responded positively to enquiries/Remedies

#### Action Taken/to be taken to Prevent the Same Issues in 2018

- Train more members of staff on how to apply weed treatment
- Have at least two team members spraying weeds in all roads within the Borough from March to October
- Respond positively to all enquiries/Remedies
- Create mobile teams to deal with significant weed growth
- A monitoring system has been created to enable the Strategic Procurement Project Manager to monitor the performance of the service against an agreed timetable of works
- Officers to investigate ways of submitting regular reports to Councillors on the performance of the service throughout the year
- Officers to investigate ways of encouraging members of the public and Councillors to report their concerns about the services using the CRM e.g. Serving You
- The budget process will investigate the feasibility of reducing the amount of grass cuts/weed spraying to the minimum level set out in the Agency Agreement

## **Grass Cutting/Weed Clearing Review**

Questions to be put to Peter Vince, Norse South East, Operations Director and Carl Mathias, Strategic Procurement Project Manager

1. Who is responsible for highway grass cutting/weed clearing?

Hampshire County Council (HCC) are directly responsible but Havant Borough Council (HBC) undertake the work as part of an Agency Agreement.

2. What is your role in the highway grass cutting/weed clearing service?

To deliver the service on behalf of HBC and in accordance with the HCC specification.

- 3. Who is responsible for monitoring the performance of the service? Chargehands, Assistant Managers, Managers and HBC Officers carry out monitoring.
- 4. What systems were in place to monitor the service?

Routine inspections by service managers.

5. What systems, if any, are in place to keep Councillors informed of the performance of the service?

Daily reports which advise of which areas have been visited and work completed.

6. Could you explain why there were problems in completing the highway grass cutting/weed clearing this year?

This year our initial weed control programme was not as successful as previous years and we were taken by surprise by the unprecedented volume of weed growth experienced. Our first window of weed treatment consisted of spraying individual weeds, which was the same approach as last year. We adopted the same principle that applies to litter picking i.e. not using personnel in areas that didn't require attention but directing the resource elsewhere to areas / locations which required more attention. This didn't work, we clearly got it wrong

- 7. What actions have you taken or do you propose to take to ensure that these problems do not reoccur?
  - We introduced 2 mobile teams of 2 people to remove \*significant weed growth. The teams work in separate areas prioritised by Managers based on site visits and information received from Customer Services, Councillors and Council Officers. This work is supplemented with week day overtime and Saturday working, when resources are available.
  - We employed a contractor to deliver our second window of weed spraying to visit each road within the Borough, this commenced on Monday 10 July.
  - We continue to provide daily information, a list of completed areas road by road, to Customer Services and HBC Liaison Officer.

 We continue to respond positively to all enquiries/Remedies i.e. addressing the concerns expressed.

\*small weeds need to remain so that weed treatment can be applied as it is most effective on established weeds.

In preparation for next year we will;

- Train members of our team to apply weed treatment
- Have at least two team members spraying weeds in all roads within the borough from March to October.
- Respond positively to all enquiries/Remedies i.e. addressing the concerns expressed.
- Have mobile teams to remove significant weed growth.
- 8. What is the budget for grass cutting in the Borough?

The Annual Sum payable to the Council by the County Council for urban grass cutting, shrubs and hedge maintenance Services on the = £201,727.00 plus a management fee of £14,008.00

9. What is the source of that budget (between HCC/HBC)?

HCC pay the full amount to HBC for undertaking work on their behalf. This is then paid to NSE in monthly instalments.

10. What (in terms of frequency/quality) does that budget fund?

HCC specify a minimum of 4 cuts, NSE target is up to 9 cuts. The frequency of grass cutting is affected by adverse weather/ground conditions. Whilst the target is 9 cuts, this will only be achieved if conditions allow for this.

11. In cost terms, how much in terms of manpower, equipment and fuel does one cut of the Borough cost?

Average cost = £28,244 per cut (avg. 3.75 weeks)

12. How long (in optimum weather conditions) does it take to complete one cut of the Borough?

Perfect weather and ground conditions - we could complete one full cut in approx. 2.5 weeks. Currently the average time taken is 3.75 weeks.

The first cut takes approx. 5 weeks. The second and thirds cuts 4 weeks each.

13. Is there a schedule of grass cutting showing which crews are cutting which areas each day, how often each area should be cut and when it was and will be cut? (I appreciate that there can't be one for the whole year as the conditions will change day by day, but there ought to be an outline one that is amended in the short term.)

14. Is there a standard set for each area or is the length of cut left to the individual operator?

**HCC Cutting Specification** 

All grass shall be cut cleanly and evenly, to the same height (approximately 25mm) on each site and without damaging the existing surface.

The *Contractor* shall complete all required grass cutting operations within each parish/ward boundary before to moving onto the next area. The parish/ward boundaries can be found on the ESRI ArcGIS shape files provided by the *Service Manager*.

The *Contractor* shall be required to re-cut any area failing to meet the requirements of this Service Activity at its own expense.

The *Contractor* shall remove all grass clippings arising deposited on paved areas, private drives, channels, etc. by a method approved by the *Service Manager*. 15. What is the budget for weed spraying in the Borough?

The Annual Sum payable to the Council by the County Council for Highway weed Treatment = £17,661 for one treatment.

16. How long does it take to complete one weed spray of the Borough?

Approx. 10 weeks, two team members working Monday to Friday visiting all roads throughout the Borough.

17. How much does one weed spray of the Borough cost?

Employing a contractor costs £16,500 per treatment.

NSE using their own team members will cost £14,645.

18. What are the quality standards for grass cutting throughout the Borough; where are they recorded (to aid Quality Assurance)?

We work to HCC standards which is recorded on 'Kahootz', although the general poor condition of highway verges prevent us from cutting shorter than 2-3 inches.

- 19. What determines areas where grass is cut and the clippings collected? This is determined within the HCC specification.
- 20. Where are the areas in the Borough where grass clippings are collected? Currently we only provide a 'cut and collect' service on two roundabouts Park Road North, Havant and Point 7, Leigh Park.
- 21. How much does it cost to repair a grass verge that has been damaged by vehicles parking on it?

HCC are responsible for the maintenance and repair of highway grass verges.

22. Is there a schedule of grass cutting showing which crews are cutting which areas each day, how often each area should be cut and when it was and will be cut?

#### **10** APOLOGIES FOR ABSENCE

No apologies for absence were received.

#### **11** MINUTES

The Panel were informed that the beach hut provision would be placed back on the Hayling Island seafront shortly, after being removed during adverse weather conditions.

#### Hampshire County Council Grass Cutting Specification

All grass shall be cut cleanly and evenly, to the same height (approximately 25mm) on each site and without damaging the existing surface.

The Contractor shall complete all required grass cutting operations within each parish/ward boundary before to moving onto the next area. The parish/ward boundaries can be found on the ESRI ArcGIS shape files provided by the Service Manager.

The Contractor shall be required to re-cut any area failing to meet the requirements of this Service Activity at its own expense.

The Contractor shall remove all grass clippings arising deposited on paved areas, private drives, channels, etc. by a method approved by the Service Manager. Generally this shall be by sweeping or by the use of a 'leaf blower'. This shall be undertaken within a reasonable timescale and by no later than the end of the day when the grass is cut. The arising shall be either removed from site and disposed or dispersed evenly over the grass surface area.

The Contractor shall leave a 100mm margin around all areas that contain visible evidence of bulbs or corms. These areas shall not be cut until a minimum period of 6 weeks has lapsed after completion of flowering.

In conditions of drought, the Contractor shall ask the Service Manager to stipulate the height that grass shall be cut for each site.

In very wet conditions, the Service Manager may request that all operations involving grass cutting shall cease, until conditions allow operations to continue without:

- i Damaging the surface, levels and contours of the ground;
- ii Creating grass cutting 'divots' from the rollers or cutters.

The Contractor shall resume normal grass cutting operations once the ground conditions become suitable again. If there is a substantial amount of mowing time lost through adverse conditions, the Contractor shall be expected to provide sufficient manpower and machinery to make the necessary progress required in order to return to the initially agreed programme. If very wet conditions persist and additional operations are required to cut grass, the Service Manager shall issue a separate instruction to the Contractor for dealing with excess growth.

The Contractor shall be responsible for ensuring that the area of grass to be cut is clear of any parked vehicles and ensure the grass cutting operations is undertaken in accordance with Volume 1, Section 5.33: Notices to the Public, Advanced Signing and Dealing with Parked Cars.

All persons operating grass cutting Equipment shall be satisfactorily trained and the Service Manager reserves the right to ask the Contractor to provide adequate proof that the operators are suitably trained, conversant with Health and Safety legislation and competent in their operating methods.

## Problems with Completing the highway grass/weed clearing in 2017

- Weather conditions led to an unprecedented volume of weed growth and at the same time limited the number of cuts/spraying that could be undertaken
- Resources directed to the wrong areas
- Complaints were not made via the CRM which made it difficult to assess the level of the problem and hotspots
- The Council did not have arrangements to monitor the performance of the service

## Actions taken in 2017 to rectify the problem

- Introduced a new team to deal with significant weed growth
- Managers prioritised areas based on site visits and information received from complainants and Customer Services
- Overtime work (if resources allowed)
- Employed a contractor
- Daily update reports circulated to Council's liaison Officer
- Responded positively to enquiries/Remedies

#### Action Taken/to be taken to Prevent the Same Issues in 2018

- Train more members of staff on how to apply weed treatment
- Have at least two team members spraying weeds in all roads within the Borough from March to October
- Respond positively to all enquiries/Remedies
- Create mobile teams to deal with significant weed growth
- A monitoring system has been created to enable the Strategic Procurement Project Manager to monitor the performance of the service against an agreed timetable of works
- Officers to investigate ways of submitting regular reports to Councillors on the performance of the service throughout the year
- Officers to investigate ways of encouraging members of the public and Councillors to report their concerns about the services using the CRM e.g. Serving You
- The budget process will investigate the feasibility of reducing the amount of grass cuts/weed spraying to the minimum level set out in the Agency Agreement
