Replacement and repair of Beach Huts damaged by Storm Eunice

1. **DECISION CATERGORY:**

Urgent Decision taken pursuant to Part Three, Section B Access to Information Standing Orders, No 63. Special Urgency

2. REASONS FOR URGENCY AND WHY NOT PRACTICABLE TO WAIT:

The necessity of re-instating Beach Hut provision ahead of the summer season.

3. DETAILS AND OUTCOME OF CONSULTATION WITH THE CHAIR/DEPUTY CHAIR OF OVERVIEW AND SCRUTINY COMMITTEE:

Discussion with and agreement by Cllr Elizabeth Lloyd, Chair of Overview and Scrutiny

4. THE DECISION:

To note the use of urgency powers by a Cabinet Member to agree to expenditure, outside of the budgetary framework, of approximately £27,547.28 to replace 8 council-owned Beach Huts irreparably damaged by Storm Eunice in February 2022 and to carry out repairs to 3 others.

5. REASONS FOR DECISION:

The reason for this decision is the urgent need to replace 8 Beach Huts that have been damaged beyond repair by Storm Eunice before the summer season starts and to repair 3 others. It would not be economic to make a claim on the council's insurance policy.

6. DETAILS OF ANY ALTERNATIVE OPTIONS CONSIDERED:

Not replacing or repairing the Huts would remove a valued facility that also produces income for the council.

Repairing Obligations

Havant Borough Council (the Council) are not under any obligation to repair or replace the

huts under the licences the Legal Officer has been provided with.

Termination

The Council can terminate the licence by notice (see clause 4.1(c)) and such termination will trigger a repayment to the licensee for the fee paid for the unexpired term. The licence is

silent on if this is a pro rata basis, but the construction of the licence appears to support that

interpretation.
